

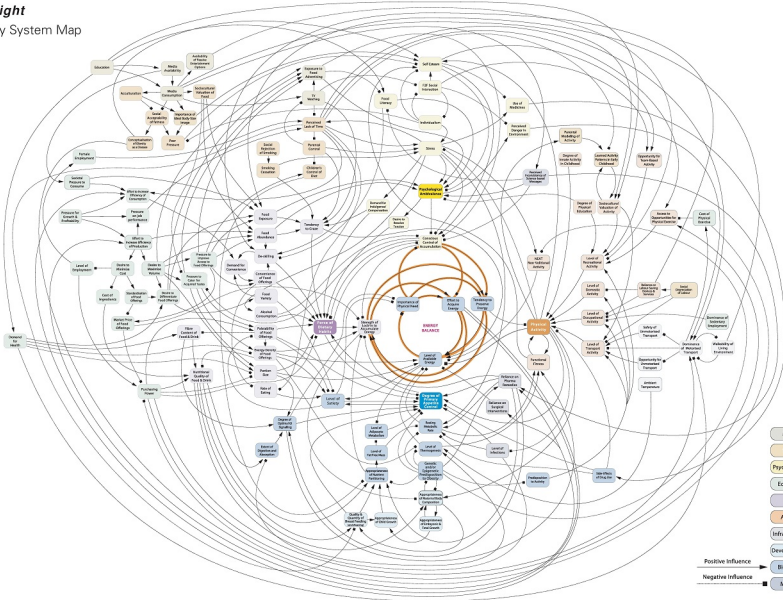

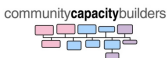

Obesity System Map

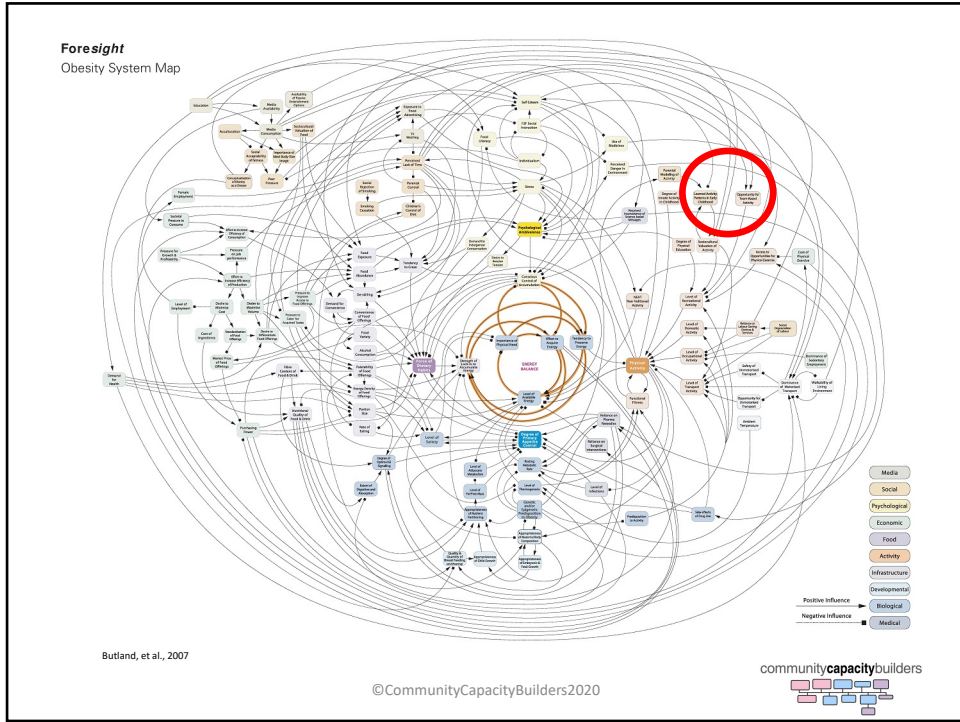

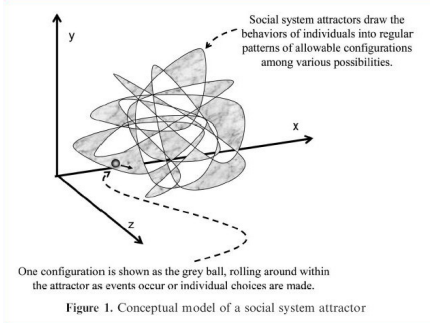
